Dr. Sroufe discussed with school board the expansion of the K-12 Virtual School up to Grade 8. This would increase enrollment to 830 from 430 virtual students. The increased revenue would be \$740,000 additional funds. Also, to set up K-12 Virtual School as its own school and not under another school.

Dr. Sroufe informed the school board that the school system had leased 275 computers at the cost of \$89,000 per year for three years, at the end of the three years, the computers will belong to the school system.

Dr. Sroufe informed the school board of a Lease Purchase option for school buses. This lease-purchase would be a five (5) year lease with a yearly payment of \$192,800. The buses would become the school systems at the end of the lease period.
