### No. 25687 <u>Superintendent's Report</u>

The school system had to revert back to the virtual mode of instruction last night. Due to the exposures, we simply did not have enough available employees at multiple work locations. We did announce last night that we intend to return to our hybrid plan of instruction on Thursday, January 28<sup>th</sup>. At this point, we still have not identified any spread of COVID in school system buildings. We have created a Dashboard with current positive cases and exposures that will be updated Wednesday of each week on our division website. This will be posted un the Families Tab with the COVID-19 information. During this time, we will deliver meals to homes as we did in August starting Tuesday, January 19<sup>th</sup>. This week, some students who have 504-plan started attending school four days a week upon approval from their parents.

It has been announced that school employees are to be vaccinated in phase 1b. We hope to begin this process for employees who want to receive the vaccine by the end of this month.

Patrick County encountered 30 new Coronavirus cases from January 8<sup>th</sup> to January 12<sup>th</sup>. As of Monday evening January 11<sup>th</sup> Patrick County has 160 active cases.
